Student Code of Conduct, Disciplinary and Exclusion Policy

Policy Statement

This policy applies to all IH Manchester students, online or in school and to all players participating in its football programmes. It also applies when they are outside the school premises, such as, during school trips, playing games or at their homestay accommodation or other residence. Please refer to our Disciplinary and Grievance Policy and Procedure in the case of unacceptable behaviour from an employee or contractor (including homestay hosts).

IH Manchester believes that everyone has a right to learn, play and work in a polite, respectful environment. We believe that everyone should be treated with dignity and respect, regardless of age, gender, ability, language, religion, race, nationality, sex, sexuality, culture or disability (more information on how the school deals with discrimination can be found in our Equality Policy, available from our website). IH Manchester will not tolerate any behaviour that affects wellbeing or the ability to learn or work (including harassment, bullying and violence).

Policy Aim

This policy ensures that students and players are aware of:

- The rules on behaviour and what is acceptable and unacceptable under the code of conduct.
- What happens if a student breaks the code of conduct i.e., disciplinary action.

Code of Conduct

IH Manchester expects everyone to follow a basic set of rules. The school will take action when these rules are broken. This procedure is described in "The Disciplinary Process" section below.

All students and players

All students and/or players (online and in school) should:

- treat themselves, other students/players, staff and their environment with respect and care.
- cooperate with other students/players, teachers, and staff. Listen to them and wait for their turn to speak.
- value and promote equality.
- attend all their classes/sessions and arrive on time.
- speak English during the class, around the school and at football.
- help create a good atmosphere for learning by participating in classes/sessions, asking for and following the advice of teachers/coaches.
- use polite language. Swear words, inappropriate topics or insults will not be tolerated.
- respect UK law, including visa laws if needed.
- only use their phone during lessons for learning.
- dress appropriately.
- behave appropriately.

Rules for online students

Online students should:

- use their name and surname on Zoom (in Latin letters).
- not share the Zoom class meeting IDs with people who are not IH Manchester students.
- be alone while attending class (not with a brother/parent/friend etc.) it is ok if they are in the room but they should not be participating.
- attend class in a quiet, appropriate environment, i.e., not in bed, on the street or in a noisy room.
- have their video on.
- never take screenshots or screen recordings of a lesson.
- switch off and mute their video when temporarily leaving the class i.e., going to the kitchen or bathroom.

The Disciplinary process

This section details what will happen if unacceptable behaviour is reported or seen. Please note that anyone in breach of the code of conduct may be temporarily removed from classes/training while an issue is being addressed. They will then be spoken to by a member of staff regarding the issue, either in person or online. For under-18s, stakeholders will be informed.

Minor or first-time incident and informal counselling

If a student/player does not follow the rules set in the code of conduct, but the issue is minor, the principal or a member of senior management may informally warn a student/player and explain the problem their behaviour is causing and give them an opportunity to change. This kind of day-to-day help is part of normal school/academy life and may not be recorded as a disciplinary issue.

Repeated or serious misbehaviour and formal action

What is a misconduct?

If minor misbehaviour continues, or if something more serious happens, this is called a misconduct. Some examples of misconduct are:

- Repeated poor attendance (please see our Attendance, Holidays and Withdrawal Policy for more details).
- Repeated use of native language in class or any behaviour that negatively affects the learning of others.
- Swearing or hurtful language.
- Repeated carelessness with facilities.
- Harassment, threatening behaviour, bullying (including peer on peer abuse) or violence.
- Hate incidents or crimes related to someone's race, disability, religion, gender identity or sexuality.
- Vandalism (destroying property) or theft.
- Drug possession, consumption or dealing.
- Smoking or drinking alcohol in class, in the school or anywhere by under 18 students.
- Breaking the law.

What happens in a case of misconduct

Interview

When misconduct is reported or seen, the school will talk to everyone involved and record discussions in writing. People involved will be able to tell the school their version of what happened. In this interview, a member of staff will be present to ask questions and take notes. If requested, another person, for example, another member of staff, another student or a personal friend can attend. A record will be kept of all interviews including the names of the people involved, the date and the time.

Results

Following the interviews, the school will use this information along with any other evidence available to make a decision. The school will decide to either:

- Take no further action.
- Give a verbal warning.
- Give a written warning.

If the behaviour reoccurs, or the problem is more serious, the school may issue a final warning or the student/player may be permanently excluded from the school/academy.

All decisions and the reasons for these are recorded in writing.

When giving warnings, the school will normally move from verbal warnings to written and then final warnings before excluding a student/player. If the incident is very serious, however, the school can skip one of more of these steps. For example, the principal can expel a student immediately, without notice or refund. The next section will explain how the school reviews evidence and makes a final decision.

Please also note that where a crime is suspected to have happened, IH Manchester will immediately contact the police.

Review of Circumstances

Before reaching a decision, we will:

- Review the evidence.
- Meet with the student/player.
- Talk with other students, players or members of staff as needed.
- Consider relevant mitigating or aggravating factors.

Here are a few possible mitigating factors:

- Was the student/player provoked, bullied or abused by others?
- Was the student/player forced or encouraged by others (peer pressure)?
- Could the student/player's medical or emotional wellbeing or their cultural background be a contributory factor?
- Is the student/player new to the school? Could they have been unaware of the seriousness of their behaviour?
- Is this the first time this has happened? How possible is it that it will happen again?
- Did the student/player admit the offence? Apologise? Did they show they are sorry and accept responsibility? Is the student/player cooperating?

And here are a few examples of possible aggravating factors:

- Having or using a weapon.
- The victim(s) was/were physically injured and/or needed medical attention.
- The victim was younger or more vulnerable.
- The student/player ignored previous warnings about their behaviour or the risk of exclusion, or refused support offered by the school.
- The offense was planned or calculated.
- The student/player shows no signs of remorse, is unwilling to accept responsibility or refuses to cooperate.

In the case of a hate incident or crime

There is a special case for hate incidents/crimes, which is explained in this section. A hate incident is an act of violence or hostility because of one of the following things:

- Disability
- Race
- Religion
- Gender identity
- Sexual orientation

Anyone who thinks this has happened to them can report it to the police, and it will be investigated as a hate incident. When hate incidents become criminal offences they are known as hate crimes. IH Manchester will assist the victim throughout – explain what their options are, assist them with reporting the incident/crime to the police, and if necessary, help them seek further help (counselling, contacting appropriate organisations or charities etc).
